Chief Complaint/HPI

<u>Nasal obstruction:</u> Patient presented with the complaint of nasal obstruction. It is located in left nares. It started 2 week(s) back. It is severe in intensity and itchy in quality.

<u>Ear Ache</u>: Patient presents with Ear Ache. It is located in right ear. It started 2 day(s) back. It is modified by antibiotics, antihistamines and OTC pain medications. Associated symptoms are fever, hearing loss, nausea and weakness.

History

MEDICAL HISTORY: Patient has a history of hypertension and DM type 2.

FAMILY HISTORY: Father has alzheimer's disease. Mother has epilepsy.

SOCIAL HISTORY: Alcohol consumption is social. Patient is current every day smoker. Smoking 2 pack/day. No illicit IV drug abuse.

SURGICAL HISTORY: Patient has history of appendectomy in 2005.

Physical Exam

CONSTITUTIONAL: Well nourished. Appropriate speech..

HEAD AND FACE: Free of masses, absent sinus tenderness, grossly normal salivary glands and symmetric facial strength.

EAR: Right ear tympanic membrane: bulging and erythematous, external ears are grossly normal, no lesion, decreased acuity in the right ear, Romberg negative and Cerebellar signs negative.



NOSE: Exam of nasal mucosa shows left deviated septum: blocking sinus drainage and normal nasal mucous membrane.



NECK: Neck is normal in symmetry and without any masses.

NEUROLOGIC: Cranial nervers (1-12) normal.

Procedures

Diagnostic nasopharyngoscopy was performed through a flexible telescope to rule out pathology and to evaluate the intranasal and nasopharyngeal structures, including the posterior aspect of the nasal cavity, eustachian tube orifice, adenoidal bed and posterior and superior oropharynx.
